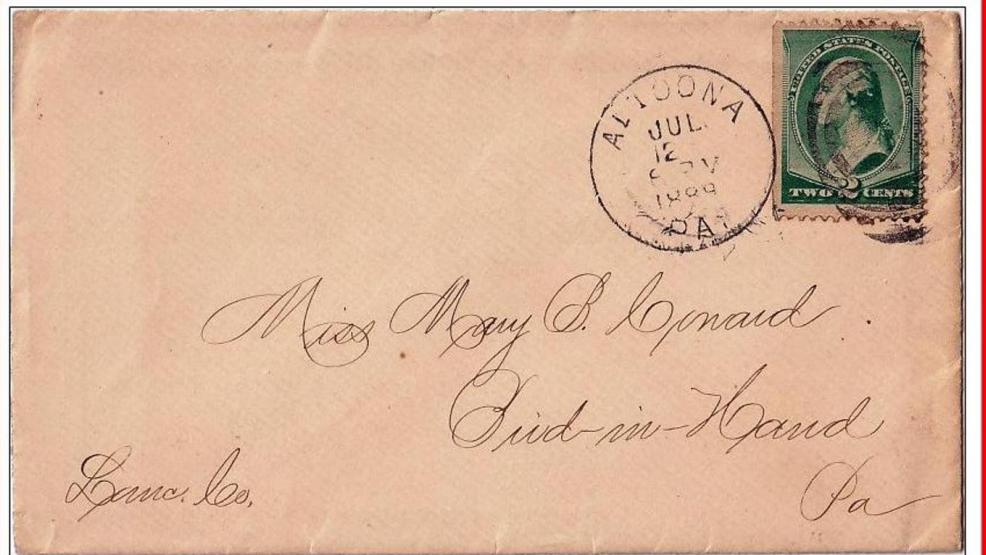


7. EXTREME BIRDS - NOW WHAT?
